Dear Secretary Mayorkas,

In light of the Supreme Court's rights-stripping decision in *Dobbs v. Jackson Women's Health Organization*, we, the undersigned organizations, write to urge you to immediately issue clear guidance that DHS *shall not* use any abortion care-related arrest or conviction as a basis for any immigration enforcement action, nor shall the agency consider it a barrier to any form of immigration relief. Furthermore, we urge you to ensure that all people held in DHS custody have timely access to the full range of reproductive health care, including abortion care, regardless of the laws of the states where they may be detained. Finally, we seek a commitment to ensuring that DHS will not deter or interfere with people's ability to safely and freely travel from and return to their states and communities of residence for abortion care, regardless of their immigration status.

The very same day the Court issued the decision, President Biden <u>condemned it in clear terms</u>, calling it "a realization of an extreme ideology and a tragic error by the Supreme Court"; stating that overturning *Roe v. Wade* would put the "health and life" of people in the U.S. "at risk"; and that the decision sent the country "back 150 years." The President then promised to do "all in [his] power" to protect the right to choose. He went on to direct his Administration to take steps to protect people seeking abortion care. The President highlighted the <u>Attorney General's statement</u> affirming that people have the right to travel outside of their states to seek abortion care and vowing that the Department of Justice would use "every tool at [their] disposal to protect reproductive freedom." The President also ordered the Secretary of Health and Human Services to take steps to protect people's access to pregnancy-ending medications and other forms of reproductive healthcare.

But as certain states rush to criminalize receiving, providing, and aiding access to abortion care, an additional danger looms for noncitizens who exercise control over their bodies and their reproductive futures, or who help others seeking the same freedom: deportation. While there is no sound legal basis for using a conviction for one of these newly created crimes as a ground for deportation or to deprive someone of relief, you must make it absolutely clear that DHS will not take *any* enforcement action against people who may be arrested for or convicted of abortion care-related crimes. You must also clarify that DHS will not consider these arrests or convictions,

or the disclosure of having obtained abortion care, to bar any form of immigration relief, including in discretionary determinations. Such clarifications are necessary to be consistent with President Biden's position: you, too, must do "all in [your] power" to protect reproductive freedom.

Under ICE & CBP agency pregnancy directives, the agency should neither detain nor take immigration enforcement action against any pregnant person in almost all cases. Adherence to this directive is especially important to ensure that pregnant people may receive whatever reproductive health care they need. For those pregnant people who remain in your custody, no matter where your agency holds them, you must also issue guidance to ensure that they have timely access to abortion care and any other reproductive health care they may require. DHS detention deprives them of the liberty to travel to another state to seek abortion care as other people may; thus it is DHS's responsibility to secure abortion care for them. Likewise, people who are under Orders of Supervision often require ICE's permission to travel out of state; your guidance should also require ICE to permit interstate travel for people who need abortion care. The horror and shame of the <u>forced gynecological procedures that were committed on ICE's watch</u> in the Irwin Detention Facility still stain your agency. You must take action to prevent other people in your custody from losing autonomy over their bodies and from being deprived of the choice to make the families they want.

Finally, immigration status checks at interior CBP checkpoints and ports of entry seriously obstruct access to abortion, which is essential health care, for undocumented pregnant people. Since Texas banned abortion last year, people seeking abortions have been forced to travel out of state for care. With bans now taking effect in multiple states following the Supreme Court's decision, many more people will be forced to travel to other US states, or out of the country, to access abortion care. It is imperative that DHS set and enforce policies that ensure that its agents do not deter or interfere with people's ability to safely and freely travel from and return to their states of residence for abortion care, regardless of their immigration status.

In order to adequately respond to the increase in cross-state and cross-border travel for abortion care, DHS should enable patients seeking time sensitive and urgent health care services, including abortion, as well as those supporting them, to access abortion care out of state or to return to the U.S. after receiving abortion care out of the country, without risk of detention or enforcement. This must protect patients from violations of privacy by federal immigration enforcement and personnel and guarantee confidentiality of medical information. It is critical that a person's travel to access this essential medical service is not used to initiate or continue removal proceedings or used against anyone in future applications for citizenship or legal status – particularly now as accessing this service without traveling a great distance becomes increasingly impossible.
